1. OVERVIEW

The 2400PSUA-8 is used to supply power to up to eight 240xLT series RF fiber optic transmitters including DC power for upstream LNBs, and/or 240xLR series fiber optic receivers. It contains dual, isolated, redundant DC power supplies and provides eight outputs on F-Type connectors. The 2400PSUA-8-WP version adds dust/water protection to IP65 for use outdoors.

Features:

- Provides isolated, redundant DC power for up to eight 240xLT/LR series modules and upstream LNBs
- Active current limit/short circuit protection of each DC output
- LED indicators display the status of each power supply and DC output
- PSU status signal output for remote monitoring via connected 2407LTA/2408LT transmitter and SmartMON[™]-enabled fiber receiver.
- Weather-proof option available for mounting outdoors




Figure 1-1: 2400PSUA-8 Block Diagram






2. INSTALLATION




Figure 2-3: 2400PSUA-8 Dimensions and Mounting Centers

The 2400PSUA-8 comes in a diecast enclosure with integral mounting flanges. It is recommended that the enclosure be mounted on a flat surface. A pair of slotted mounting holes is provided on the DC-output side of the unit, and a single slotted mounting hole is accessible on the AC-input side of the unit, centered between the two AC connectors. See Figure 2-3 for mounting hole and dimensional information.

The 2400PSUA-8 is intended for installation in dry locations, protected from direct rain/moisture. The 2400PSUA-8-WP version is sealed and protected to IP65, allowing installation outdoors.

2.1. 2400PSUA-8 CONNECTIONS

AC IN 1+2: 100 to 240 VAC, 50/60 Hz, auto-ranging AC inputs. Each input is separately connected to one of the internal, redundant AC/DC power supplies. The dual connectors should be connected to separate AC branch circuits to permit fully redundant power.

Two outdoor rated cable assemblies with mating connectors are included. Cables are available with NEMA5-15P, as well as UK or Schuko style connectors for worldwide applications.

For 2400PSUA-8-WP units installed outdoors, unconnected AC input connectors must be protected by attaching the captive sealing caps (received with the unit) in order to prevent moisture ingest into the unit.

DC Outputs: Eight output F-Type connectors for DC power connections to 240xLT/LR's. Each output features active short-circuit and overload protection.



For 2400PSUA-8-WP units installed outdoors, unconnected DC ouput connectors must be protected by attaching the captive sealing caps (received with the unit) in order to prevent moisture ingest into the unit.

4. STATUS INDICATORS

The 2400PSUA-8 has ten LED status indicators on the front of the box to show operational status of the module at a glance.

4.1. PSU1 AND PSU2 INDICATORS

The PSU1 and PSU2 LEDs indicate the status of the internal power supplies:

- **GREEN:** Internal power supply associated with the LED is operating normally.
- **RED:** Internal power supply associated with the LED has failed or is not receiving AC input.
- **OFF:** If both PSU1 and PSU2 LEDs are OFF, this indicates that there is no power input to the unit at either AC connector, or both internal power supplies have failed.

4.2. UNIT 1-8 INDICATORS

The UNIT 1-8 LEDs indicate the status of each DC output:

- **GREEN:** Output associated with the LED is operating normally.
- **RED:** Load connected to output associated with the LED is excessive or short circuited.
- **OFF:** If all UNIT 1-8 LEDs are off, this indicates that there is no power supplied to the unit on either AC connector, or both internal power supplies have failed.
